

4. Any discrepancy found during document verification shall lead to cancellation of candidature without further notice.
5. No candidate shall be allowed to appear in the interview without proper document verification.
6. **No TA/DA** will be admissible for appearing in the interview.
7. The decision of the competent authority shall be final and binding in all matters related to the recruitment process.
